THE CLERC CENTER CONSISTS OF THE MODEL SECONDARY SCHOOL FOR THE DEAF AND KENDALL DEMONSTRATION ELEMENTARY SCHOOL. IN THE FALL SEMESTER OF ACADEMIC YEAR 2023-2024, THE UNIVERSITY ENROLLED 875 UNDERGRADUATE STUDENTS, 460 GRADUATE STUDENTS, AND 19 ENGLISH LANGUAGE INSTITUTE STUDENTS. THE CLERC CENTER HAD 91 STUDENTS ENROLLED AT KENDALL DEMONSTRATION ELEMENTARY SCHOOL AND 139 STUDENTS ENROLLED AT THE MODEL SECONDARY SCHOOL FOR THE DEAF.
